Valuation for Traditional Retail Insurance Replacement

Item 1

One, pair of lady's hand-assembled raised, 9ct yellow gold & gemset, earrings.

Feature, "drop style" clip-back pierced earrings. Each comprising, a square-shaped, box top, with an open back, drops to an articulated ribbon bow motif to middle, below suspended a long four claw railed setting, each setting contains one emerald cut natural emeral, heavily included, claw set. Both with plain post fitted, to top behind & hinged clip to back.

Polished finish, unstamped - acid tested & x-rayed approximately 9 carat gold.

Earrings dimensions = 26.50mm (total length) x 7.36mm (width) x 3.38mm (depth).

The earrings contain:

Two claw set emerald cut natural emeralds, colour is "medium dark green opaque".
Dimensions = 7.81mm (L) x 6.91mm (W) x 4.06mm (D-estimated)
Total Weight = 2.92ct (estimated - see NOTE below).

Two claw set emerald cut natural emeralds, colour is "medium dark green opaque".
Dimensions = 8.50mm (L) x 5.95mm (W) x 5.49mm (D-estimated)
Total Weight = 3.70ct (estimated - see NOTE below).

Total Item Weight = 3.79 grams, Total Gemstone Weight = 6.62ct, Total Metal Weight = 2.47 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar pair of drop style earrings employing similar materials and techniques being for a retail insurance purpose only.
