Valuation for Traditional Retail Insurance Replacement

Item 1

One, hand-assembled, 18ct yellow gold and 18ct white gold, dress style, gem set ring.

Plain, narrow, tapered band of 1.79mm in width (at base) x 0.96mm depth, with open back settings.

Feature central bezel setting, having a white gold top plate, housing one round brilliant cut diamond, rub-over set. To each side is a bezel setting, rub-over set with one baguette cut diamond. All secured between the shoulders of the plain and polished band.



Polished finish - stamped '750' - acid tested as 18 carat gold. Finger size is R 1/2.

The ring contains:

One rub over set round brilliant cut diamond, clarity 'Si2', colour 'H'.

Dimensions = 5.53mm(L) x 5.50mm(W) x 3.31mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.63ct (estimated - see NOTE below)

Two rub over set baguette cut diamonds, clarity 'Vs', colour 'G to H' (mixed).

Dimensions (average) = 2.80mm(L) x 1.96mm(W) x 1.25mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.13ct (estimated - see NOTE below)

Total Item Weight = 3.66 grams - Total Gemstone Weight = 0.76ct - Total Metal Weight = 3.51 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
