## Valuation for Traditional Retail Insurance Replacement

### Item 1

One, hand-assembled, 14ct white gold, multistone, gem set ring. Plain, narrow, tapered band of 1.64mm in width (at base) x 0.98mm depth, with closed back underrail.

Feature central four claw setting, housing four Princess cut diamonds, invisible set. Surrounded by twelve round brilliant cut diamonds, bead set. Each extended shoulder of the plain and polished band having five round brilliant cut diamonds, tapering in size, largest to smallest, bead set. The setting underrail and shoulder sides, all having a decorative carved design.



Polished finish - stamped 'Q6 14K michael hill' - acid tested as 14 carat gold. Finger size is O 1/2.

The ring contains:

Four invisible set Princess cut diamonds, clarity 'Vs & Si' (mixed), colour 'H'.  
Dimensions (average) = 2.35mm(L) x 2.35mm(W) x 1.45mm(D-estimated) x 2%(Girdle Thickness)  
Total Weight = 0.30ct (estimated - see NOTE below)

Twenty Two bead set round brilliant cut diamonds, clarity 'SI & P1' (mixed), colour 'H' (mixed).  
Dimensions = 1.70mm(Dia) x 1.04mm(D-estimated) x 2%(Girdle Thickness) (smallest)  
Dimensions = 2.40mm(Dia) x 1.46mm(D-estimated) x 2%(Girdle Thickness) (largest)  
Total Weight = 0.70ct (estimated - see NOTE below)

Total Item Weight = 5.14 grams - Total Gemstone Weight = 1.00ct - Total Metal Weight = 4.94 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only.
