One, lady's hand finished, raised 18ct yellow and white gold & diamond set, solitaire ring. Plain, narrow, low half round, tapered band, measures 2.23mm width (at base) x 1.02mm depth, with curved underrail.

Feature, "solitaire style" ring design. Comprising, a raised six claw white gold railed setting, to top. The extended shoulders, of the yellow gold band, tapers up to pointed end terminations, to each side.

Polished finish, stamped "750" - acid tetsed as 18 carat gold.

Finger size = L.

the ring contains;

One claw set round brilliant cut diamond, clarity is "Si2", colour is "J", medium cut quality.
Dimensions = 4.68mm (diameter) x 3.00mm (D-estimated) x 8%(Girdle Thickness)
Total Weight = 0.45ct (estimated - see NOTE below).

Total Item Weight = 3.06 grams, Total Gemstone Weight = 0.45ct, Total Metal Weight = 2.97 grams (estimated)



NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the diamond cannot be ascertained. Therefore, weight of the diamond are very much estimated. For accurate testing, weights, colour, and clarity gradings, the diamond, would require removal from the setting.
