## Valuation for Traditional Retail Insurance Replacement

### Item 1

One, lady's hand-assembled raised, 18ct yellow and white gold, diamond set, solitaire ring. Plain, narrow, low half round, tapered band, measures 2.00mm width (at base) x 0.98mm depth, with curved underrail.

Feature, "solitaire style".. Comprising, a raised four cal white gold setting to top. Housing one round brilliant cut diamond, (laser inscribed) claw set. The extended shoulders, of the yellow gold band, tapers up to pointed end terminations, from both sides.

Polished finish, stamped "750" - acid tested as 18 carat gold.

Finger size = H.

The ring contains:

- One claw set round brilliant cut diamond, clarity is "Si2", colour is "G", very good cut quality.
- Dimensions = 5.44 - 5.53mm (diameter) x 3.47mm (D-estimated)
- Total Weight = 0.65ct (estimated - see NOTE below).

Total Item Weight = 2.01 grams, Total Gemstone Weight = 0.65ct, Total Metal Weight = 1.88 grams (estimated)

NOTE: The round brilliant cut diamond, has been certified by, and is the opinion of, Messrs. Gemological Institute of America, Certificate no.2156829114 Dated October, 03, 2013. The diamond has also been laser inscribed upon the girdle with GIA (logo) and 2156829114, & partial 28433, under a claw. Due to setting constraints, the exact dimensions of the gemstone cannot be ascertained. Therefore, weights of the gemstone are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstone require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
