## Valuation for Traditional Retail Insurance Replacement

## Item 1

One, 18ct white gold, gem set, 'cluster' style ring, of hand-assembled construction.

Plain, narrow, low half round, tapered band of 4.67mm width (at base) x 0.93mm depth, with open back settings.

Feature assymetrical cluster ring. There is a total of fourteen baguette cut and tapered baguette cut diamonds, end set, and a total of forty-seven round brilliant cut diamonds, claw set, randomly arranged across the top of the band. The settings are supported with an open wire base, and are secured to the top of the plain and polished band.



Polished finish. Stamped '18K 04206 unknown makers mark' - acid tested 18 carat gold. Ring size: P 1/2.

The ring contains:

Fourteen end set baguette cut and tpaered baguette cut diamonds, clarity is "Vs & Si & P1" (mixed), colour is "G to H" (mixed).

Dimensions = 2.74mm(L) x 1.55mm(W) x 1.13mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 3.07mm(L) x 1.55mm(W) x 1.13mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.50ct (estimated - see NOTE below)

Forty Seven claw set round brilliant cut diamonds, clarity is "Si & P1 & P2" (mixed), colour is "G".

Dimensions (average) = 1.35mm(Dia) x 0.82mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.50ct (estimated - see NOTE below)

Total Item Weight = 11.56 grams Total Gemstone Weight = 1.00ct Total Metal Weight = 11.34 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only.
