### Valuation for Traditional Retail Insurance Replacement

#### Item 1

One, hand-assembled, 9ct yellow gold and 9ct white gold, diamond set pendant.

Feature white gold multi-claw settings, consisting of illusion plates, each illusion set with one round brilliant cut diamond, tapering in size. Having a yellow gold decorative 'petal' style frame, then articulated from the tapering bail assembly.

Polished finish - stamped '9K JP164' - acid tested as 9 carat gold.

Pendant dimensions = 28.00mm (length including bail) x 17.45mm (width) x 6.60mm (depth).

The pendant contains:

Fifteen illusion set round brilliant cut diamonds, clarity 'P1 & P2' (mixed), colour 'G to I' (mixed).

Dimensions = 1.80mm(Dia) x 1.10mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 2.50mm(Dia) x 1.53mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.50ct (estimated - see NOTE below)

Total Item Weight = 2.61 grams

Total Gemstone Weight = 0.50ct

Total Metal Weight = 2.51 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar pendant employing similar materials and techniques being for a retail insurance purpose only.
