Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct white gold pendant, of hand-assembled construction.

Feature round top plate, with a central four claw setting, housing one round brilliant cut diamond, claw set. Surrounding is one row of fifteen round brilliant cut diamonds, claw set. The pendant is finished with an articulated bail, housing one row of four round brilliant diamond, graduating in size, and claw set.

Pendant dimensions = 14.00mm (ave. length) x 7.84mm (ave. width) x 4.05mm (ave. depth).

Polished finish.

Stamped 'WB750 AD diamond motif' - acid tested as 18 carat gold.

The pendant contains:

One claw set round brilliant cut diamond, clarity is "Si1", colour is "light tinted brown".

Dimensions = 4.10mm(L) x 4.08mm(W) x 2.35mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.24ct (estimated - see NOTE below)

Nineteen claw set round brilliant cut diamonds, clarity is "P1 & P2" (mixed), colour is "H to J" (mixed).

Dimensions = 2.02mm(Dia) x 1.23mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 1.25mm(Dia) x 0.76mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.26ct (estimated - see NOTE below)

Total Item Weight = 0.92 grams

Total Gemstone Weight = 0.50ct

Total Metal Weight = 0.83 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar pendant employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
