Valuation for Traditional Retail Insurance Replacement

Item 1

One lady's, hand-assembled raised, 18ct yellow and white gold & diamond set, solitaire ring.

Plain, narrow, low half round band, measures 2.00mm width (at base) x 1.12mm depth with curved underrail.

Feature, "solitaire style" ring design. Comprising, a raised white gold, rub-over setting to top, houses one Princess cut diamond, rub-over set. The extended shoulders, of the yellow gold band, tapers up to pointed end terminations to both sides.



Polished finish, stamped "18ct" - acid tested as 18 carat gold.

Finger size = M1/2.

The ring contains;

One rub-over set Princess cut diamond, clarity is "Si", colour is "H", medium cut quality.

Dimensions = 3.92mm (L) x 3.92mm (W) x 2.78mm (D-estimated) Total Weight = 0.34ct (estimated - see NOTE below).

Total Item Weight = 2.97 grams, Total Gemstone Weight = 0.34ct, Total Metal Weight = 2.90 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the diamond cannot be ascertained. Therefore, weight of the diamond are very much estimated. For accurate testing, weights, colour, and clarity gradings, the diamond, would require removal from the setting. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
