Valuation for Traditional Retail Insurance Replacement

Item 1

One lady's, hand-assembled raised, 10ct rose gold & gemstone set, multistone ring. Plain, narrow, low half round, tapered band, measures 1.82mm width (at base) x 1.10mm depth, with curved underrail.

Feature, "solitaire style", ring design, with shoulder stones. Comprising, a raised four claw setting to centre, houses one round, brilliant cut diamond (treated blue), claw set. The extended shoulders, of the band, tapers up to the top. Each shoulder having three rows, top & sides. Each shoulder contains twenty two round brilliant cut diamonds, claw set, both sides.

Polished finish, stamped "10K" -acid tested approximately 10 carat gold. Finger size = M.

the ring contains;

One claw set round brilliant cut diamond, clarity is "P2", colour is "treated blue", medium cut quality.
 Dimensions = 6.79mm (average diameter) x 4.14mm (D-estimated)
 Total Weight = 1.16ct (estimated - see NOTE below).

Forty Four claw set round brilliant cut diamonds, clarity is "P1, P2 & P3"(mixed), colour is "G to I"(mixed), medium cut quality.
 Dimensions = 1.16mm (average diameter) x 0.71mm (D-estimated) (smallest)
 Dimensions = 1.75mm (average diameter) x 1.07mm (D-estimated) (largest)
 Total Weight = 0.66ct (estimated - see NOTE below).

Total Item Weight = 2.98 grams, Total Gemstone Weight = 1.82ct, Total Metal Weight = 2.62 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the diamonds cannot be ascertained. Therefore, weight of the diamonds are very much estimated. For accurate testing, weights, colour, and clarity gradings, the diamonds require removal from the settings. The below replacement figure is based upon crafting a ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
