Valuation for Traditional Retail Insurance Replacement

Item 1

One, pair of hand crafted, 18ct white gold & gemset, drop pierced earrings.

Feature, South Sea cultured pearl studs, with diamond set, enhancer & an articulated, South Sea cultured pearl drop. Both earrings, with plain post & butterfly disks attached.

Polished finish, unstamped - acid tested & x-rayed.

Earring dimensions = 25.00mm (L) x 11.50mm (W) x 15.20mm (D).

The earring contains:

Four end-drilled round South Sea cultured medium white/cream pearls (mixed), lustre is "High-Medium", blemish is "Few blemishes-Lightly spotted", very good matching.

Dimensions = 10.56mm (average diameter) (smallest)

Dimensions = 11.23mm (average diameter) (largest)
(estimated - see NOTE below).

Eighteen bead set round brilliant cut diamonds, clarity is "Si", colour is "H to I"(mixed), medium cut quality.

Dimensions = 1.60mm (average diameter) x 0.98mm (D-estimated) (smallest)

Dimensions = 2.00mm (average diameter) x 1.22mm (D-estimated) (largest)

Total Weight = 0.45ct (estimated - see NOTE below).

Total Item Weight = 14.27 grams.

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar pair of earrings employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
