## Valuation for Traditional Retail Insurance Replacement

### Item 1

One lady's, hand finished, raised 14ct white gold & gemset, multistone ring, of cast construction. Plain, narrow, low half round, tapered band, measures, 2.27mm width (at base) x 1.44mm depth, with curved underrail. Feature circular cluster with shoulder stones, Housing one round brilliant cut diamonds, claw set to centre. Drops to a double surround contains twenty seven round brilliant cut diamonds, claw set. The extended shoulders, of the band, tapers up to the top, each shoulder containing four round brilliant cut diamonds, claw set, both sides. Polished finish, stamped "14K, MHJ" - acid tested as 14 carat gold. Finger size = L.



The ring contains;

One claw set round brilliant cut diamond, clarity is "P2", colour is "H", medium cut quality.

Dimensions = 3.70mm (average diameter) x 2.26mm (D-estimated)

Total Weight = 0.19ct (estimated - see NOTE below).

Twenty Seven claw set round brilliant cut diamonds, clarity is "P1, P2 & P3"(mixed), colour is "G to H"(mixed), medium cut quality.

Dimensions = 1.22mm (average diameter) x 0.74mm (D-estimated) (smallest)

Dimensions = 1.66mm (average diameter) x 1.01mm (D-estimated) (largest)

Total Weight = 0.38ct (estimated - see NOTE below).

Eight claw set round brilliant cut diamonds, clarity is "P2 & P3"(mixed), colour is "G to H"(mixed), medium cut quality.

Dimensions = 2.35mm (average diameter) x 1.43mm (D-estimated)

Total Weight = 0.38ct (estimated - see NOTE below).

Total Item Weight = 4.45 grams, Total Gemstone Weight = 0.95ct, Total Metal Weight = 4.26 grams (estimated)

NOTE: Limited gemmological testing inset. Due to setting constraints, the exact dimensions of the diamonds cannot be ascertained. Therefore, weight of the diamonds are very much estimated. For accurate testing, weights, colour, and clarity gradings, the diamonds, would require removal from the setting. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
