Valuation for Traditional Retail Insurance Replacement

Item 1

One, lady's hand assembled raised, 14ct yellow gold & gemset, multistone ring.

Plain, narrow, flat, tapered band, measures 2.32mm width (at base) x 0.99mm depth, with curved underrail.

Feature, 'solitaire style" with shoulder stones. Comprising, a v-claw setting to front centre, angled, housing one marquise cut diamond, v-claw set. The extended shoulders, of the band tapers up. One shoulder fluted with, four round brilliant cut diamond, channel set. The other shoulder, contains six round brilliant cut diamonds, channel set.



Polished finish, stamped "14K" - acid tested as 14 carat gold. Finger size = Q1/2.

The ring contains;

One claw set marquise cut diamond, clarity is "Vs", colour is "K/L" (yellow tint), medium cut quality.

Dimensions = 5.34mm (L) x 3.28mm (W) x 2.24mm (D-estimated)

Total Weight = 0.25ct (estimated - see NOTE below).

Ten channel set round brilliant cut diamonds, clarity is "P2 & P3"(mixed), colour is "H to J"(mixed), medium cut quality.

Dimensions = 1.74mm (average diameter) x 1.06mm (D-estimated)

Total Weight = 0.20ct (estimated - see NOTE below).

Total Item Weight = 3.20 grams, Total Gemstone Weight = 0.45ct, Total Metal Weight = 3.12 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
