Valuation for Traditional Retail Insurance Replacement

Item 1

One, lady's hand-assembled, 10ct yellow gold & gemset, flexible link necklet.

Feature, "scatter rub-over settings" to front, housing thirteen round brilliant cut diamonds, rub-over set, various sizes. The necklet having a bolt ring clasp attached to back.

Polished finish, stamped "10K" - acid tested as approximately 10 carat gold.

Necklet dimensions = 56.00cm (total length) x 0.38mm (width) x 0.17mm (depth).

The necklet contains:

Thirteen rub-over set round brilliant cut diamonds, clarity is "Si & P1" (mixed), colour is "H to I" (mixed), medium cut quality.

Dimensions = 1.70mm (average diameter) x 1.04mm (D-estimated) (smallest)

Dimensions = 3.20mm (average diameter) x 1.95mm (D-estimated) (largest)

Total Weight = 0.52ct (estimated - see NOTE below).

Total Item Weight = 1.59 grams, Total Gemstone Weight = 0.52ct, Total Metal Weight = 1.49 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the diamonds cannot be ascertained. Therefore, weight of the diamonds are very much estimated. For accurate testing, weights, colour, and clarity gradings, the diamonds, would require removal from the setting. The below replacement figure is based upon crafting a similar necklet employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
