One, 18ct yellow gold, gem set, 'solitaire' style ring, of cast construction.

Plain, narrow, low half round band of 2.05mm width (at base) x 0.79mm depth, with a hollow top and shoulders, and an open back setting.

Feature central bezel setting, housing one round brilliant cut diamond, bezel set. The setting is secured to the top of the band. The shoulders are embellished with 'twist' style detail.

Polished finish.

Unstamped - acid tested 18 carat gold.

Ring size: N.

The ring contains:

One bezel set round brilliant cut diamond, clarity is "P1", colour is "H".
Dimensions = 3.60mm(Dia) x 2.35mm(D-estimated) x 2%(Girdle Thickness)
Total Weight = 0.19ct (estimated - see NOTE below)

Total Item Weight = 3.48 grams
Total Gemstone Weight = 0.19ct
Total Metal Weight = 3.44 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstone cannot be ascertained. Therefore, weight of the gemstone is very much an estimation. For an accurate weight, colour, and clarity grading, the gemstone requires removal from the setting. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
