### Valuation for Traditional Retail Insurance Replacement

#### Item 1

One, hand assembled, 9ct yellow gold and 9ct white gold, multi-stone, ring set, of cast construction. The set comprising a 9ct yellow gold and 9ct white gold diamond set engagement ring with a fitted and matching 9ct yellow gold and 9ct white gold diamond set wedding and eternity rings. Each ring having a plain, narrow, low half round band with a combined basal width of 5.00mm x 1.02mm in depth.



The engagement ring has three 'flower' style clusters, graduating in size, largest to the centre, spanning across the top of the band. Each cluster houses seven round brilliant cut diamonds, largest diamond to the centre, in white gold settings, claw set. The settings are secured between the extended and tapering and 'split' style shoulders of the plain and polished yellow gold band. The fitted and matching wedding and eternity rings are identical. There are three 'scallop' shaped white gold top plates, each housing three round brilliant cut diamonds, in shared claw settings, claw set. The settings are secured between the 'split' style shoulders of the plain and polished yellow gold band. The wedding and eternity rings sit alongside the engagement ring above.

Polished finish. Stamped 'maple leaf motif 18CT MHJ' - acid tested as 18 carat gold. Ring size: R.

#### The ring contains:

One claw set round brilliant cut diamond, clarity is "P2", colour is "I".

Dimensions = 2.50mm(Dia) x 1.53mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.06ct (estimated - see NOTE below)

Thirty Eight claw set round brilliant cut diamonds, clarity is "Si & P1 & P2" (mixed), colour is "I to J" (mixed).

Dimensions = 1.62mm(Dia) x 0.99mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 2.05mm(Dia) x 1.25mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.83ct (estimated - see NOTE below)

Total Item Weight = 8.72 grams Total Gemstone Weight = 0.89ct Total Metal Weight = 8.54 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring set employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
