Valuation for Traditional Retail Insurance Replacement

Item 1

One, 14ct white gold, diamond set, multistone ring, of cast construction.

Plain, narrow, low half round, tapered band of 1.38mm width (at base) x 1.61mm depth, with open back settings, and a cut out underrail.

Feature central four claw setting, housing one round brilliant cut diamond, claw set. The setting is secured between the extended and tapering shoulders, of the plain and polished band. Each of the shoulders houses four round brilliant cut diamonds, graduating in size, and bead set. There is millegrain detail to the edges of the shoulders.

Polished finish.

Stamped 'DG 14K D0.23 Together Forever' - acid tested as 14 carat gold.

Ring size: L.

The ring contains:

One claw set round brilliant cut diamond, clarity is "Si2", colour is "J".

Dimensions = 5.78mm(L) x 5.75mm(W) x 3.51mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.70ct (estimated - see NOTE below)

Eight bead set round brilliant cut diamonds, clarity is "Vs & Si" (mixed), colour is "G to H" (mixed).

Dimensions = 1.40mm(Dia) x 0.85mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 2.35mm(Dia) x 1.43mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.23ct (estimated - see NOTE below)

Total Item Weight = 3.03 grams Total Gemstone Weight = 0.93ct Total Metal Weight = 2.84 grams (estimated)

NOTE: The diamond has been certified by Messrs. Gemological Institute of America (GIA) Certificate number: 1206152339 Dated: March 25, 2019. The diamond has also been laser inscribed upon the girdle with GIA (logo) and 1206152339. No diamond certificate or paperwork was presented at the time of this valuation. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
