## Valuation for Traditional Retail Insurance Replacement

## Item 1

One, 18ct yellow gold, multistone ring, of hand-assembled consruction.

Plain, narrow, low half round, tapered band of 2.05mm width (at base) x 1.07mm depth, with open back settings.

Feature central bezel setting, housing one round brilliant cut diamond, bezel set. The setting is secured between the extended and square shoulders, of the plain and polished band. Each of the shoulders houses two round brilliant cut diamonds, channel set.



Polished finish.

Stamped '750 Australian map motif S' - acid tested as 18 carat gold.

Ring size: N.

The ring contains:

Five bezel and channel set round brilliant cut diamonds, clarity is "Si & P1 & P2" (mixed), colour is "G to H" (mixed).

Dimensions = 2.74mm(Dia) x 1.67mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 2.92mm(Dia) x 1.78mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.39ct (estimated - see NOTE below)

Total Item Weight = 3.17 grams

Total Gemstone Weight = 0.39ct

Total Metal Weight = 3.09 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only.
