### Valuation for Traditional Retail Insurance Replacement

#### Item 1

One, 18ct yellow gold, gem set, multistone ring, of cast construction.

Plain, narrow, low half round, tapered band of 1.62mm width (at base) x 1.18mm depth, with a hollow top and shoulders, and open back settings.

Feature one row of twelve Princess cut diamonds, spanning across the top of the band, and channel set. The settings are secured between the shoulders of the plain and polished band.

Polished finish.

Stamped '750 WB' - acid tested as 18 carat gold.

Ring size: N.

The ring contains:

Twelve channel set Princess cut diamonds, clarity is "Si & P1 & P2" (mixed), colour is "H to I" (mixed).  
Dimensions (average) = 1.73mm(L) x 1.73mm(W) x 1.23mm(D-estimated) x 2%(Girdle Thickness)  
Total Weight = 0.36ct (estimated - see NOTE below)

Total Item Weight = 3.13 grams Total Gemstone Weight = 0.36ct Total Metal Weight = 3.06 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
