1 x 18ct yellow and white gold wrap around flow-up style bridal set.
The main ring is set with 1 x 5.20mm [0.50mct] round brilliant cut diamond set in a raised 6 claw white gold setting.
The shank is rounded and reverse tapers from 1.95mm - 2.25mm wide.
The Eternity ring is set with 1 x 3.00mm [0.13ct], 2 x 2.25mm [0.06ct] and 2 x 2.00mm [0.04ct] round cut Sapphire's claw set in a curved pattern in the white gold setting.
The shank is rounded and tapers from 2.15mm - 1.95mm wide.
