Valuation for Traditional Retail Insurance Replacement

Item 1

One, 9ct yellow gold and rhodium plated, cluster style, gem set, dress ring.

Plain, wide, tapered band of 3.00mm in width (at base) x 1.27mm depth, with hollow top and shoulders, and open back settings.

Feature three 'cluster' style settings, each housing seven round brilliant cut diamonds, centres sunken set, surrounds claw set. The central extended shoulder row, each having five round brilliant cut diamonds, tapering in size, claw set. Each outer row spanning across the top of the plain and polished band, also claw set with twenty-three round brilliant cut and single cut (mixed) diamonds.

Polished finish - unstamped - acid tested as 9 carat gold. Finger size is J 1/2.

The ring contains:

- Seventy Seven sunken set & claw set (mixed) round brilliant cut diamonds, clarity 'Si, P1 & P2' (mixed), colour 'H to I' (mixed).
Dimensions = 0.90mm(Dia) x 0.55mm(D-estimated) x 2%(Girdle Thickness) (smallest)
- Dimensions = 2.40mm(Dia) x 1.46mm(D-estimated) x 2%(Girdle Thickness) (largest)
- Total Weight = 1.00ct (estimated - see NOTE below)

Total Item Weight = 4.46 grams
Total Gemstone Weight = 1.00ct
Total Metal Weight = 4.26 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
