## Valuation for Traditional Retail Insurance Replacement

### Item 1

One, lady's hand finished, raised 18ct white gold & diamond set, multistone ring. Plain, narrow, low half round, tapered band, measures, 2.04mm width (at base) x 0.89mm depth, with curved underrail, open back settings, under each shoulder.

Feature, "solitaire style" with shoulder stones. Comprising, a raised end v-setting to top, houses one Princess cut diamond, End set. The extended shoulders, of the band taper up to the top. Each shoulder contains five Princess cut diamonds, channel set, both sides.

Polished finish, stamped "750, AC16" - acid tested as 18 carat gold.

Finger size = N.

The ring contains;

One end set Princess cut diamond, clarity is "Vs2", colour is "H", medium cut quality.  
Dimensions = 4.00mm (L) x 3.89mm (W) x 2.76mm (D-estimated)  
Total Weight = 0.40ct (estimated - see NOTE below).

Ten channel set Princess cut diamonds, clarity is "Vs & Si"(mixed), colour is "H to I"(mixed), medium cut quality.  
Average dimensions = 1.77mm (L) x 1.82mm (W) x 1.29mm (D-estimated)  
Total Weight = 0.35ct (estimated - see NOTE below).

Total Item Weight = 3.92 grams, Total Gemstone Weight = 0.75ct, Total Metal Weight = 3.77 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the diamonds cannot be ascertained. Therefore, weight of the diamonds are very much estimated. For accurate testing, weights, colour, and clarity gradings, the diamonds; would require removal from the setting. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
