One, platinum, gem set, 'solitaire' style ring, of hand-assembled construction.

Plain, narrow, low half round band of 1.91mm width (at base) x 1.67mm depth, with a curved underrail.

Feature central railed four claw setting, housing one round brilliant cut diamond, claw set. The setting is secured between the extended and pointed shoulders, of the plain and polished band.

Polished finish.

Stamped 'c Cartier 0.50ct D 50CS TVB032 Pt950 CBS(manufacturing mark)' - acid tested as platinum.
Ring size: J 1/2.

The ring contains:

One claw set round brilliant cut diamond, clarity is "Vs1", colour is "H".

Dimensions = 5.08mm(L) x 5.07mm(W) x 3.15mm(D-estimated) x 4%(Girdle Thickness)

Total Weight = 0.50ct (known weight - see NOTE below)

Total Item Weight = 4.49 grams Total Gemstone Weight = 0.50ct Total Metal Weight = 4.39 grams (estimated)
