## Valuation for Traditional Retail Insurance Replacement

### Item 1

One pair of, 10ct yellow gold, gem set, multistone, hoop style earrings, of hand-assembled construction.

Feature elongated style hinged hoop, housing one row of eleven round brilliant cut diamonds, graduating in size, and channel set. The earrings are finished with post and clip attachments.

Earrings dimensions = 25.00mm (ave. length) x 3.44mm (W) x 2.37mm(D).

Polished finish.

Stamped '10K MHJ' - acid tested as approximately 10 carat gold.

The earrings contain:

Twenty Two channel set round brilliant cut diamonds, clarity is "P1 & P2 & P3" (mixed), colour is "light tinted brown".

Dimensions = 2.10mm(Dia) x 1.28mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 2.50mm(Dia) x 1.53mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 1.00ct (estimated - see NOTE below)

Total Item Weight = 5.00 grams Total Gemstone Weight = 1.00ct Total Metal Weight = 4.80 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar pair of earrings employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
