Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct yellow gold and rhodium plated, 'three stone' style ring, of construction.

Plain, narrow, low half round band of 2.12mm width (at base) x 1.11mm depth, with open back settings.

Feature three bezel settings, spanning across the top of the band, graduating in size, largest to the centre. Each of the settings houses one round brilliant cut diamond, end set. The settings are secured between the shoulders of the plain and polished band. The shoulders are embellished with 'strap' detail. Rhodium plating to the central settings.

Polished finish.

Stamped '750 MM' - acid tested as 18 carat gold.

Ring size: N.

The ring contains:

One end set round brilliant cut diamond, clarity is "P1", colour is "H".

Dimensions = 3.82mm(Dia) x 2.27mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.21ct (estimated - see NOTE below)

Two end set round brilliant cut diamonds, clarity is "Si & P1" (mixed), colour is "H".

Dimensions (average) = 2.95mm(Dia) x 1.70mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.22ct (estimated - see NOTE below)

Total Item Weight = 3.39 grams Total Gemstone Weight = 0.43ct Total Metal Weight = 3.30 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
