One, single hand-assembled raised, 18ct white gold & gemset, screw-back stud earring.

Feature; "single round screw back stud" earring. Comprising, a four claw cup style setting, housing one round brilliant cut, "laboratory grown" synthetic diamond, claw set. The stud having a threaded post and butterfly, fitting attached..

Polished finish, stamped "750" - acid tested as 18 carat gold.

Earring dimensions = 6.80mm (diameter) x 4.81mm (depth).

The stud earring contains:

One claw set round brilliant cut diamond, clarity is "Vs", colour is "G+", good cut quality.

Dimensions = 5.08mm (diameter) x 3.10mm (D-estimated)

Total Weight = 0.50ct (estimated - see NOTE below).

Total Item Weight = 1.15 grams, Total Gemstone Weight = 0.50ct, Total Metal Weight = 1.05 grams (estimated)

NOTE: Limited gemmological testing inset. ID the gemstone as a "laboratory grown synthetic diamond". Due to setting constraints, the exact dimensions of the "laboratory synthetic grown diamond" cannot be ascertained. Therefore, weight of the "laboratory grown synthetic diamond", are very much estimated. For accurate testing, weights, colour, and clarity gradings, the "laboratory grown synthetic diamond, would require removal from the setting. The below replacement figure is based upon crafting a similar single stud earring, employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
