Valuation for Traditional Retail Insurance Replacement

Item 1

One, 10ct yellow gold and rhodium plated, multistone ring, of hand-assembled construction.

Plain, narrow, low half round, tapered band of 3.02mm width (at base) x 1.21mm depth, with open back settings, and a curved cut out underrail.

Feature three rows of thirteen round brilliant cut diamonds, graduating in size, and channel set, alternating with four rows of twenty-five single cut diamonds, claw set. The settings are secured between the tapering shoulders, of the plain and polished band. Rhodium plating to the diamond setting areas.

Polished finish.

Stamped '10K 1.00 michael hill' - acid tested as 10 carat gold.

Ring size: N 1/2.

The ring contains:

One Hundred claw set single cut diamonds, clarity is "P1 & P2" (mixed), colour is "H to light tinted brown" (mixed).

Dimensions (average) = 0.95mm (diameter)

Total Weight = 0.45ct (estimated - see NOTE below)

Thirty Nine channel set round brilliant cut diamonds, clarity is "Si & P1" (mixed), colour is "H to light tinted brown" (mixed).

Dimensions = 1.35mm(Dia) x 0.82mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 1.98mm(Dia) x 1.21mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.55ct (estimated - see NOTE below)

Total Item Weight = 5.34 grams Total Gemstone Weight = 1.00ct Total Metal Weight = 5.15 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
