Valuation for Traditional Retail Insurance Replacement

Item 1

One, 9ct yellow gold and 9ct white gold, gem set, 'cluster' style ring, of hand-assembled construction.

Plain, narrow, low half round, tapered band of 2.39mm width (at base) x 1.32mm depth, with open back settings, and a curved underrail.

Feature round white gold top plate, within a six claw setting, housing eleven round brilliant cut diamonds, varying in size, largest to the centre, invisibly and claw set. The setting is secured to the underrail, and in between the knife-edge shoulders, of the plain and polished yellow gold band.

Polished finish. Stamped '375 JP02' - acid tested as 9 carat gold. Ring size: O.

The ring contains:

Six invisibly and claw set round brilliant cut diamonds, clarity is "P1 & P2" (mixed), colour is "H to I" (mixed).
Dimensions (average) = 2.85mm(Dia) x 1.74mm(D-estimated) x 2%(Girdle Thickness)
Total Weight = 0.54ct (estimated - see NOTE below)

Five claw set round brilliant cut diamonds, clarity is "P1 & P2" (mixed), colour is "H to I" (mixed).
Dimensions (average) = 1.26mm(Dia) x 0.77mm(D-estimated) x 2%(Girdle Thickness)
Total Weight = 0.06ct (estimated - see NOTE below)

Total Item Weight = 4.21 grams Total Gemstone Weight = 0.60ct Total Metal Weight = 4.09 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
