Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct yellow gold and platinum, gem set, 'cluster' style ring, of hand-assembled construction.

Plain, narrow, flat, low half round, tapered band of 2.72mm width (at base) x 1.12mm depth, with open back settings, and a curved underrail.

Feature central platinum top plate, with a central four claw setting, housing one oval natural garnet, claw set. Surrounding is one row of eight round brilliant cut diamonds, claw set. The top plate is supported with an open wire base, and is secured to the underrail. The upswept and square shoulders extend out from the plain and polished yellow gold band.

Polished finish.

Stamped 'CATANACH'S 18CT P PLAT' - acid tested as 18 carat gold, and platinum.

Ring size: S.

The ring contains:

Eight claw set round brilliant cut diamonds, clarity is "Vs & Si" (mixed), colour is "G to H" (mixed).

Dimensions (average) = 2.90mm(Dia) x 1.77mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.80ct (estimated - see NOTE below)

One claw set oval shaped natural garnet, "purple".

Dimensions = 6.88mm(L) x 5.76mm(W) x 3.51mm(D-estimated)

Total Weight = 1.17ct (estimated - see NOTE below)



Total Item Weight = 7.78 grams Total Gemstone Weight = 1.97ct Total Metal Weight = 7.39 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
