Valuation for Traditional Retail Insurance Replacement

Item 1

One, lady's hand finished raised, 18ct yellow gold & diamond set, three stone ring. Plain, narrow, half round, tapered band, measures 2.95mm width (at base) x 0.84mm depth, with open back, underneath, central setting is rhodium plated to highlight. Drops to each side a three claw setting contains one round brilliant cut diamond, claw set. The extended shoulders, of the band, tapers up wide, terminates with a pointed end, ribbed to centre, both sides.

Polished finish, stamped "18ct" - acid tested as 18 carat gold.

Finger size = N.

The ring contains;

One rub-over set round brilliant cut diamond, clarity is "P2", colour is "M", medium cut quality.
Dimensions = 6.10mm (diameter) x 3.67mm (D-estimated)
Total Weight = 0.83ct (estimated - see NOTE below).

Two claw set round brilliant cut diamonds, clarity is "P1 & P2" (mixed), colour is "tint light brown", medium cut quality.
Dimensions = 2.50mm (average diameter) x 1.53mm (D-estimated)
Total Weight = 0.12ct (estimated - see NOTE below).

Total Item Weight = 3.52 grams, Total Gemstone Weight = 0.95ct, Total Metal Weight = 3.33 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the diamonds cannot be ascertained. Therefore, weight of the diamonds are very much estimated. For accurate testing, weights, colour, and clarity gradings, the diamonds, would require removal from the setting. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
