Valuation for Traditional Retail Insurance Replacement

One, 18ct rose gold, gem set, multistone ring, of cast construction

Plain, narrow, low half round band of 3.67mm width (at base) x 1.30mm depth, with open back settings.

Feature one row of twelve round brilliant cut diamonds, spanning across the top of the band. The diamonds vary slightly in size, and are channel set. The settings are secured between the shoulders of the plain and polished band.



Polished finish.

Stamped '18KT' - acid tested as 18 carat gold.

Ring size: O.

The ring contains:

Twelve channel set round brilliant cut diamonds, clarity is "Vs & Si" (mixed), colour is "H". Dimensions (average) = 2.50mm(Dia) x 1.53mm(D-estimated) x 2%(Girdle Thickness) Total Weight = 0.75ct (estimated - see NOTE below)

Total Item Weight = 4.82 grams Total Gemstone Weight = 0.75ct Total Metal Weight = 4.68 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only.
