Valuation for Traditional Retail Insurance Replacement

Item 1

One, 14ct white gold, gem set, 'cluster' style ring, of cast construction.

Plain, narrow, low half round, tapered band of 1.96mm width (at base) x 1.22mm depth, with open back settings, and a decorative underrail.

Feature cushion shaped top plate, with a central four claw setting, housing one round brilliant cut diamond, claw set. Surrounding is one floating row of sixteen round brilliant cut diamonds, claw set. The top plate is secured to the underrail, and in between the 'split' style shoulders, of the plain and polished band. The gallery and the shoulders are embellished with a total of fourteen round brilliant cut diamonds, varying in size, bezel and claw set. There is a low relief pattern, and millegrain to the edges.



Polished finish.

Stamped '14K michael hill 1.05' - acid tested as 14 carat gold.

Ring size: O.

The ring contains:

One claw set round brilliant cut diamond, clarity is "P1", colour is "I".

Dimensions = 5.01mm(L) x 4.98mm(W) x 3.29mm(D-estimated) x 5.8%(Girdle Thickness)

Total Weight = 0.52ct (known weight - see NOTE below)

Forty Two claw set round brilliant cut diamonds, clarity is "Si & P1 & P2" (mixed), colour is "H to I" (mixed).

Dimensions = 1.40mm(Dia) x 0.85mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 2.01mm(Dia) x 1.23mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.53ct (estimated - see NOTE below)

Total Item Weight = 4.67 grams Total Gemstone Weight = 1.05ct Total Metal Weight = 4.46 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
