Valuation for Traditional Retail Insurance Replacement

Item 1

One, hand-assembled, 9ct yellow gold, dress style, gem set ring.

Plain, narrow, tapered band of 2.35mm in width (at base) x 0.85mm depth, with open back settings.

Feature central semi bezel setting, housing one oval cut and faceted amethyst, semi rub-over set. To either side is three round brilliant cut diamonds, bead set. All secured between the shoulders of the plain and polished band.



Polished finish - stamped '9CT' - acid tested as 9 carat gold. Finger size is O.

The ring contains:

One semi bezel set mixed cut oval shape amethyst, colour 'dark amethyst.

Dimensions = 8.85mm(L) x 7.38mm(W) x 3.99mm(D-estimated)

Total Weight = 1.52ct (estimated - see NOTE below)

Six bead set round brilliant cut diamonds, clarity 'P1 & P2' (mixed), colour 'brown tint'.

Dimensions (average) = 1.60mm(Dia) x 0.98mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.10ct (estimated - see NOTE below)

Total Item Weight = 3.60 grams - Total Gemstone Weight = 1.62ct - Total Metal Weight = 3.28 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
