Valuation for Traditional Retail Insurance Replacement

Item 1

One, lady's, hand finished, raised 9ct two-tone gold (white & rose), diamond set, cluster dress ring. Plain, narrow, low half round, tapered band, measures 2.07mm width (at base) x 1.52mm depth, with curved underrail, open back settings, underneath.

Feature, "cluster style" ring design. Comprising, a raised, four claw setting to top, houses four Princess cut diamonds, illusion/claw set. The extended shoulders, of the band, tapers up wide, splits to four rails. The centre rails, each side, two cross-over in rose gold. The two outer rows, are running across the top, of the band, contains thirty one round brilliant cut diamonds, bead set, both sides.



Polished finish, stamped "9K D" - acid tested as 9 carat gold. Finger size = O.

The ring contains;

Four illusion set Princess cut diamonds, clarity is "Si & P1"(mixed), colour is "H to I"(mixed), medium cut quality.
Average dimensions = 1.85mm (L) x 1.85mm (W) x 1.31mm (D-estimated)
Total Weight = 0.14ct (estimated - see NOTE below).

Sixty Two bead set round brilliant cut diamonds, clarity is "Si & P1"(mixed), colour is "H to I"(mixed), medium cut quality.
Dimensions = 0.90mm (average diameter) x 0.55mm (D-estimated) (smallest)
Dimensions = 1.20mm (average diameter) x 0.73mm (D-estimated) (largest)
Total Weight = 0.36ct (estimated - see NOTE below).

Total Item Weight = 4.20 grams, Total Gemstone Weight = 0.50ct, Total Metal Weight = 4.10 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
