Valuation for Traditional Retail Insurance Replacement

Item 1

One lady's, hand finished, raised 18ct yellow and white gold, diamond set, cluster dress ring. Plain, narrow, low half round, tapered band, measures 2.01mm width (at base) x 0.89mm depth, with curved underrail.

Feature, cluster style" ring design, with shoulder stones. Comprising, a raised, rub-over white gold setting to top, houses one Princess cut diamond, Drops to a square shaped, bead set surround. The extended shoulders, of the band, tapers up to the top, from both sides.

Polished finish, stamped "750" - acid tested as 18 carat gold.

Finger size = M.

The ring contains;

One rub-over set Princess cut diamond, clarity is "P1", colour is "I", medium cut quality.
Dimensions = 3.70mm (L) x 3.70mm (W) x 2.63mm (D-estimated)
Total Weight = 0.30ct (estimated - see NOTE below).

Twenty Eight bead set round brilliant cut diamonds, clarity is "Si", colour is "H to I"(mixed), medium cut quality.
Dimensions = 1.00mm (average diameter) x 0.61mm (D-estimated) (smallest)
Dimensions = 1.60mm (average diameter) x 0.98mm (D-estimated) (largest)
Total Weight = 0.30ct (estimated - see NOTE below).

Total Item Weight = 3.06 grams, Total Gemstone Weight = 0.60ct, Total Metal Weight = 2.95 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
