Valuation for Traditional Retail Insurance Replacement

Item 1

One pair of hand-assembled, 18ct white gold, diamond set, 'stud' style earrings.

Feature each earring consisting of a four claw railed setting, housing one round brilliant cut diamond, slightly varying in size, claw set.

Post and butterfly fittings attached.

Polished finish.

Stamped '750' acid tested as 18 carat gold.

Earring dimensions = 3.70mm (width) x 4.10mm (depth).

The earrings contain:

Two claw set round brilliant cut diamonds, clarity 'Si & P1' (mixed), colour 'G'.
Dimensions = 3.69mm(L) x 3.67mm(W) x 2.24mm(D-estimated) x 2.5%(Girdle Thickness)
Total Weight = 0.40ct (estimated - see NOTE below)

Total Item Weight = 1.10 grmas

Total Gemstone Weight = 0.40ct

Total Metal Weight = 1.02 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar pair of earrings employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
