Valuation for Traditional Retail Insurance Replacement

Item 1

One, hand-assembled, 18ct yellow gold and 18ct white gold, three diamond ring.

Plain, narrow, tapered band of 2.03mm in width (at base) x 0.96mm depth.

Feature three individual white gold four claw railed settings, each housing one round brilliant cut diamond, largest to the centre, sides slightly varying, all claw set. Secured between the shoulders of the yellow gold plain and polished band.

Polished finish - stamped '18K michael hill H51062 1.00' - acid tested as 18 carat gold. Finger size is M.

The ring contains:

One claw set round brilliant cut diamond, clarity 'P1', colour 'I'.

Dimensions = 5.51mm(L) x 5.47mm(W) x 3.48mm(D-estimated) x 4.4%(Girdle Thickness)

Total Weight = 0.65ct (known weight - see NOTE below)

Two claw set round brilliant cut diamonds, clarity 'P1 & P2' (mixed), colour 'H'.

Dimensions (average) = 3.75mm(Dia) x 2.20mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.35ct (estimated - see NOTE below)

Total Item Weight = 3.01 grams - Total Gemstone Weight = 1.00ct - Total Metal Weight = 2.81 grams (estimated)

NOTE: The centre diamond has been certified by Messrs. Australian Diamond Grading Laboratory (ADGL) Certificate number: H51062 Dated: 07/08/2014. The centre diamond has also been laser inscribed upon the girdle with ADGL michael hill and H51062. Due to setting constraints, the exact dimensions of the side diamonds cannot be ascertained. Therefore, weights of the side diamonds are very much estimated. For accurate testing, weights, colour, and clarity gradings, the side diamonds require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
