## Valuation for Traditional Retail Insurance Replacement

### Item 1

One, hand-assembled, 9ct yellow gold and 9ct white gold, cluster style, gem set, dress ring.

Plain, narrow, tapered band of 1.75mm in width (at base) x 0.88mm depth, with curved underrail, open at each shoulder.

Feature white gold four claw 'cluster' style setting, housing nine round brilliant cut diamonds, largest to the centre, claw set. Secured between the extended shoulders of the yellow gold plain and polished band.

Polished finish - stamped '375 .15CT JP42' - acid tested as 9 carat gold. Finger size is O.

The ring contains:

One claw set round brilliant cut diamond, clarity 'Si1', colour 'G'.  
Dimensions = 2.50mm(Dia) x 1.53mm(D-estimated) x 2%(Girdle Thickness)  
Total Weight = 0.06ct (estimated - see NOTE below)

Eight claw set round brilliant cut diamonds, clarity 'Si & P1' (mixed), colour 'G to H' (mixed).  
Dimensions (average) = 1.45mm(Dia) x 0.88mm(D-estimated) x 2%(Girdle Thickness)  
Total Weight = 0.09ct (estimated - see NOTE below)

Total Item Weight = 2.14 grams - Total Gemstone Weight = 0.15ct - Total Metal Weight = 2.11 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
