## Valuation for Traditional Retail Insurance Replacement

## Item 1

One, 18ct white gold, diamond set, multistone ring, of hand-assembled construction.

Plain, narrow, low half round, flat, tapered band of 2.44mm width (at base) x 0.78mm depth, with a curved underrail.

Feature central illusion plate within a six claw setting, housing one round brilliant cut diamond, illusion set. The setting is secured to the underrail, of the plain and polished band. Each of the upswept and square shoulders, houses two single cut diamonds, bead set.



Polished finish.

Stamped '18ct' - acid tested as 18 carat gold.

Ring size: L 1/2.

The ring contains:

One illusion set round brilliant cut diamond, clarity is "Vs", colour is "H".

Dimensions = 3.48mm(L) x 3.45mm(W) x 1.95mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.15ct (estimated - see NOTE below)

Four bead set single cut diamonds, clarity is "Si", colour is "H to I" (mixed).

Dimensions (average) = 1.20mm (diameter)

Total Weight = 0.03ct (estimated - see NOTE below)

Total Item Weight = 4.01 grams Total Gemstone Weight = 0.18ct Total Metal Weight = 3.97 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
