## Valuation for Traditional Retail Insurance Replacement

## Item 1

One, 9ct yellow gold, multistone, gem set ring, of cast construction. Plain, wide, tapered band of 11.63mm at top to 3.71mm in width (at base) x 1.22mm depth, with hollow top and shoulders, and open back settings.

Feature multi-row ring design, consisting of two inner rows, housing a total of twenty-eight baguette cut & tapered baguette cut (mixed) diamonds, in groups of two, finishing with a group of three at each end. Alternating with ten round brilliant cut diamonds, all channel set. The outer row each side having fifteen round brilliant cut diamonds, tapering in size, also channel set.



Polished finish - stamped '375' - acid tested as 9 carat gold. Finger size is N.

The ring contains:

Twenty Eight channel set baguette cut & tapered baguette cut (mixed) diamonds, clarity 'Vs & Si' (mixed), colour 'H to J' (mixed).

Dimensions = 1.70mm(L) x 1.10mm(W) x 0.60mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 2.15mm(L) x 1.32mm(W) x 0.75mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.50ct (estimated - see NOTE below)

Forty channel set round brilliant cut diamonds, clarity 'Si, P1 & P2' (mixed), colour 'J to K' (mixed).

Dimensions = 1.40mm(Dia) x 0.85mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 2.25mm(Dia) x 1.37mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.50ct (estimated - see NOTE below)

Total Item Weight = 6.67 grams - Total Gemstone Weight = 1.00ct - Total Metal Weight = 6.47 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
