## Valuation for Traditional Retail Insurance Replacement

### Item 1

One pair, of lady's hand-assembled raised, 10ct rose gold & diamond set, hoop earrings.

Feature, 'drop hoop' style earrings. Comprising, a channel setting to front, each contain twelve round brilliant cut diamonds, channel set. Both with plain post & hinged base clip, fitted & attached.

Polished finish, stamped "10K MHJ" - acid tested approximately 10 carat gold.

Earring dimensions = 20.79mm (L) x 2.83mm (W) x 1.95mm (D).

The earrings contains:

Twenty Four channel set round brilliant cut diamonds, clarity is "P1 & P2"(mixed), colour is "G to I"(mixed), medium cut quality.

Dimensions = 1.52mm (average diameter) x 0.93mm (D-estimated) (smallest)

Dimensions = 1.83mm (average diameter) x 1.12mm (D-estimated) (largest)

Total Weight = 0.55ct (estimated - see NOTE below).

Total Item Weight = 3.55 grams, Total Gemstone Weight = 0.55ct, Total Metal Weight = 3.44 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the diamonds cannot be ascertained. Therefore, weight of the diamonds are very much estimated. For accurate testing, weights, colour, and clarity gradings, the diamonds would require removal from the setting. The below replacement figure is based upon crafting a similar pair of hoop earrings employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
