### Valuation for Traditional Retail Insurance Replacement

#### Item 1

One, 9ct yellow gold and rhodium plated, gem set, 'cluster' style ring, of cast construction.

Plain, wide, low half round, tapered band of 4.47mm width (at base) x 1.34mm depth, with a hollow top and shoulders, open back settings, and a curved underrail.

Feature central round top plate, within a four claw setting, housing sixteen round brilliant cut diamonds, varying in size, claw set. The setting is secured to the underrail and in between the tri-split style shoulders, of the plain and polished band. Each of the shoulders houses one row of ten tapered baguette cut diamonds, slightly graduating in size and channel set. The two bands either side of the central setting houses one row of thirteen round brilliant cut diamonds, channel set. Rhodium plating to the diamond setting areas.



Polished finish. Stamped '025 9K 1.25ct unknown makers mark' - acid tested as 9 carat. Ring size: S.

#### The ring contains:

Forty Two claw and channel set round brilliant cut diamonds, clarity is "P1 & P2 & P3" (mixed), colour is "G to H" (mixed).

Dimensions = 1.50mm(Dia) x 0.92mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 2.60mm(Dia) x 1.59mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 1.00ct (estimated - see NOTE below)

Twenty channel set tapered baguette cut diamonds, clarity is "Si & P1" (mixed), colour is "G to H" (mixed).

Dimensions = 1.70mm(L) x 1.00mm(W) x 0.73mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 2.30mm(L) x 1.20mm(W) x 0.88mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.25ct (estimated - see NOTE below)

Total Item Weight = 9.40 grams Total Gemstone Weight = 1.25ct Total Metal Weight = 9.15 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
