Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct white gold, gem set, 'cluster' style ring, of cast construction.

Plain, narrow, low half round, tapered band of 1.10mm width (at base) x 0.97mm depth, with a hollow top and shoulders, open back settings, and a curved underrail.

Feature pear shaped top plate, housing eleven round brilliant cut diamonds, varying in size, invisibly and claw set. Surrounding is one row of twenty-two round brilliant cut diamonds, claw set. The top plate is secured between the extended and square shoulders, of the plain and polished band. Each of the shoulders houses one row of five round brilliant cut diamonds, graduating in size, and claw set.

Polished finish.

Stamped '18K' - acid tested as 18 carat gold.

Ring size: L.

The ring contains:

Five claw set round brilliant cut diamonds, clarity is "P1 & P2" (mixed), colour is "G to H" (mixed).

Dimensions = 2.30mm(Dia) x 1.40mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 2.45mm(Dia) x 1.49mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.25ct (estimated - see NOTE below)

Thirty Eight claw set round brilliant cut diamonds, clarity is "Si & P1 & P2 & P3" (mixed), colour is "G to H" (mixed).

Dimensions = 1.00mm(Dia) x 0.61mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 2.14mm(Dia) x 1.06mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.75ct (estimated - see NOTE below)

Total Item Weight = 2.23 grams Total Gemstone Weight = 1.00ct Total Metal Weight = 2.10 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
