Valuation for Traditional Retail Insurance Replacement

Item 1

One, 9ct white gold, gem set, multistone ring, of cast construction.

Plain, narrow, low half round, tapered band of 3.19mm width (at base) x 1.19mm depth, with a hollow top and shoulders, and open back settings.

Feature five rows with a total of forty-two round brilliant cut diamonds, spanning across the top of the band, varying in size, and claw set. The settings are secured between the tapering shoulders, of the plain and polished band.



Polished finish.

Stamped '375 AC16' - acid tested as 9 carat gold.

Ring size: N.

The ring contains:

Forty Two claw set round brilliant cut diamonds, clarity is "Si & P1" (mixed), colour is "H to I" (mixed).

Dimensions = 1.63mm(Dia) x 0.99mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 1.75mm(Dia) x 1.07mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 1.00ct (estimated - see NOTE below)

Total Item Weight = 3.61 grams Total Gemstone Weight = 1.00ct

Total Metal Weight = 3.41 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only.
