Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct white gold, gem set, 'three stone' style ring, of hand-assembled construction.

Plain, narrow, low half round band of 2.48mm width (at base) x 1.23mm depth, with open back settings.

Feature three sweeping four claw settings, spanning across the top of the band. Each housing one Princess cut diamond, graduating in size, largest to the centre, claw set. The settings are secured between extended and pointed shoulders, of the plain and polished band.

Polished finish.

Stamped 'MHJ 750 H03034 1.00' - acid tested as 18 carat gold.

Ring size: L 1/2.

The ring contains:

One claw set Princess cut diamond, clarity is "Si1", colour is "I".

Dimensions = 4.46mm(L) x 4.44mm(W) x 3.29mm(D-estimated) x 2.5%(Girdle Thickness)

Total Weight = 0.55ct (estimated - see NOTE below)

Two claw set Princess cut diamonds, clarity is "Vs", colour is "H to I" (mixed).

Dimensions (average) = 3.39mm(L) x 3.39mm(W) x 2.41mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.45ct (estimated - see NOTE below)

Total Item Weight = 3.85 grams Total Gemstone Weight = 1.00ct Total Metal Weight = 3.65 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
