Valuation for Traditional Retail Insurance Replacement

Item 1

One, lady's hand finished, raised 9ct yellow gold & diamond set, multistone ring. Plain, narrow, low half round, tapered band, measures 2.16mm width (at base) x 1.15mm depth, with curved underrail.

Feature; "illusion cluster style" with shoulder stones. Comprising, a raised pear-shaped cluster setting to top, rhodium plated to highlight, houses one round brilliant cut diamond, claw set. A surround contains eight round brilliant cut diamonds, bead set. The extended shoulders, of the band tapers up to pointed end terminations, each shoulder contains six round brilliant cut diamonds, bead set both sides.

Polished finish, stamped "375, JP88" - acid tested as 9 carat gold.

Finger size = O.

The ring contains;

One claw set round brilliant cut diamond, clarity is "Si", colour is "J", medium cut quality.
Dimensions = 3.30mm (average diameter) x 2.01mm (D-estimated)
Total Weight = 0.13ct (estimated - see NOTE below).

Twenty bead set round brilliant cut diamonds, clarity is "Si & P1"(mixed), colour is "H to J"(mixed), medium cut quality.
Dimensions = 1.15mm (average diameter) x 0.70mm (D-estimated) (smallest)
Dimensions = 2.00mm (average diameter) x 1.22mm (D-estimated) (largest)
Total Weight = 0.37ct (estimated - see NOTE below).

Total Item Weight = 3.03 grams, Total Gemstone Weight = 0.50ct, Total Metal Weight = 2.92 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the diamonds cannot be ascertained. Therefore, weight of the diamonds are very much estimated. For accurate testing, weights, colour, and clarity gradings, the diamonds, would require removal from the setting. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
