Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct yellow gold and rhodium plated, gem set, 'cluster' style ring, of hand-assembled

Plain, narrow, low half round, tapered band of 1.88mm width (at base) x 1.16mm depth, with a hollow top and shoulders, open back settings, and a curved underrail.

Feature square top plate within a four claw setting, housing four Princess cut diamonds, invisibly set. The settingis secured to the underrail, and the tapering shoulders extend out from the plain and polished band. Each of the shoulder houses one row of four round brilliant cut diamonds, graduating in size, and channel set. Rhodium plating to the top plate, and diamond setting areas.



Polished finish. Stamped '18K' - acid tested as 18 carat gold. Ring size: P.

The ring contains:

Four invisibly set Princess cut diamonds, clarity is "Si & P1" (mixed), colour is "G to H" (mixed).

Dimensions (average) = 2.70mm(L) x 2.70mm(W) x 1.92mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.46ct (estimated - see NOTE below)

Eight channel set round brilliant cut diamonds, clarity is "Si & P1 & P2" (mixed), colour is "G to H" (mixed).

Dimensions = 2.00mm(Dia) x 1.22mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 2.26mm(Dia) x 1.38mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.27ct (estimated - see NOTE below)

Total Item Weight = 5.23 grams Total Gemstone Weight = 0.73ct Total Metal Weight = 5.08 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
