One, 14ct white gold, gem set, 'cluster' style ring, of hand-assembled construction.

Plain, narrow, low half round band of 1.46mm width (at base) x 1.27mm depth, with a curved underrail.

Feature oval top plate, housing eighteen round brilliant cut diamonds, varying in size, claw set. The double surround and shoulders house seventy round brilliant cut diamonds, also vary in size, and claw set. The top plate is secured to the upswept shoulders, of the plain and polished band.



Polished finish. Stamped '14K 0.89 michael hill' - acid tested as 14 carat gold. Ring size: O.
