## Valuation for Traditional Retail Insurance Replacement

### Item 1

One, lady's, 2pce ring set, hand-assembled raised, 14ct two-tone gold & diamond set, multistone rings. Plain, narrow, low half round, tapered bands, combined basal width 2.18mm width (at base) x 0.87mm depth, with underrails.

Feature, "2pce ring set". Comprising, a raised four claw setting, to centre. The extended shoulders, of the band, tapers up to the top, splits both sides, with a plain rose gold rail to centre. The complimenting band, having a contoured shape, with a single bead set row to top.

Polished finish, stamped "MHJ 14K (faded) - acid tested both as 14 carat gold. Finger size = Q.

The ring contains;

One claw set round brilliant cut diamond, clarity is "P2", colour is "G to H"(mixed), medium cut quality.  
Dimensions = 4.68mm (Diameter) x 2.85mm (D-estimated)  
Total Weight = 0.38ct (estimated - see NOTE below).

Fifty Seven bead set round brilliant cut diamonds, clarity is "P2", colour is "G to H"(mixed), medium cut quality.  
Dimensions = 1.14mm (average diameter) x 0.70mm (D-estimated) (smallest)  
Dimensions = 1.24mm (average diameter) x 0.76mm (D-estimated) (largest)  
Total Weight = 0.29ct (estimated - see NOTE below).

Total Item Weight = 5.00 grams, Total Gemstone Weight = 0.67ct, Total Metal Weight = 4.87 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar 2pce ring set, employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
