Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct yellow gold, diamond set, multistone ring, of cast construction.

Plain, narrow, low half round band 2.02mm width (at base) x 0.94mm depth, with open back (cut-out) settings, and supported with a curved underrail.

Feature one central raised four claw setting, housing one Princess cut diamond, claw set. The central setting is secured between upswept shoulders. The band houses ten Princess cut diamonds, spanning across the top, underneath the central setting, channel set.

Polished finish, stamped '750 AC16' - acid tested as 18 carat gold.

Ring size: R.

The ring contains:

One claw set Princess cut diamond, clarity is "P1", colour is "J".

Dimensions = 3.98mm(L) x 3.95mm(W) x 2.80mm(D-estimated) x 3%(Girdle Thickness)

Total Weight = 0.38ct (estimated - see NOTE below)

Ten channel set Princess cut diamonds, clarity is "P1" (mixed), colour is "J to K" (mixed).

Dimensions (average) = 2.00mm(L) x 2.00mm(W) x 1.42mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.42ct (estimated - see NOTE below)

Total Item Weight = 4.30 grams Total Gemstone Weight = 0.80ct Total Metal Weight = 4.14 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
